

ELDER DALLIN H. OAKS SPEAKS AT 2011 RELIGION & THE LAW SYMPOSIUM AT CHAPMAN UNIVERSITY

In what has been described as a landmark address, Elder Dallin H. Oaks spoke at this year's Orange County Religion & The Law Symposium, on "Preserving Religious Freedom". The event was held on February 4, 2011, in the 900+seat Memorial Hall at Chapman University, and was sponsored by the J. Reuben Clark Law Society, Orange County Chapter, as well as a wide range of diverse societies and law schools valuing religion and the law. Following his speech, Elder Oaks was a special guest on the Hugh Hewitt radio show where he was warmly and graciously received.

Elder Oaks commenced his speech by affirming the importance of religion and the free exercise thereof, citing its contributions to charitable works, moral advances such as the abolition of slavery, and the strengthening of our nation in matters of

honesty and integrity. He stated, "Our society is not held together just by law and its enforcement, but most importantly by voluntary obedience to the unenforceable and by widespread adherence to unwritten norms of right or righteous behavior".

Elder Oaks noted that the "free exercise" of religion is "the dominating civil liberty" and has a "pre-eminent place as the first expression in the First Amendment to the United States Constitution [which] identifies freedom of religion as 'a cornerstone of American democracy".

Sounding a voice of warning, Elder Oaks continued that, "[n]otwithstanding its special place in our Constitution, a number of trends are eroding both the protections the free exercise clause was intended to provide and the public esteem this fundamental value has had during our history". He noted that "[f]or some time we have been experiencing laws and official actions that impinge on religious freedom", and then gave numerous examples of its demise.

## FEDERAL DISTRICT COURT JUDGE INSTRUCTS THAT "DECEPTION PERVERTS JUSTICE"

On November 18, 2010, Judge Cormac Carney of the USDC instructed Chapter members about the pitfalls of dishonest lawyering and how deception perverts justice. Judge Carney, a former standout receiver for UCLA, laid out three primary ways in which lawyers all too often deceive the Court – i.e., by: (1) misrepresenting facts, (2) arguing by technicality, and (3) grossly exaggerating their positions.

Judge Carney advised that once an attorney loses credibility, he or she can never get it back. He remarked that while he does not often impose sanctions for lying, he always remembers the dishonesty later.

He then gave five reasons not to deceive the Court. First, "You'll get caught by the Judge or the opposition". Second, "The truth sells, lies do not". Third, "It's disrespectful to the Court. Fourth, "It demeans the attorney who lies". And fifth, "It's unhealthy".

## PRESERVING RELIGIOUS FREEDOM (Con't)

Elder Oaks cited the cause of this weakening or erosion as being "attributable to the ascendancy of moral relativism".

He urged that "[w]e must never see the day when the public square is not open to religious ideas and religious persons" and that "[t]he religious community must unite to be sure we are not coerced or deterred into silence by the kinds of intimidation or threatening rhetoric that are being experienced". Such actions are "anti-religious" and "surely anti-democratic and should be condemned by all who are interested in democratic government".

Finally, Elder Oaks remarked, "as an Apostle of the Lord Jesus Christ I affirm his love for all people of this earth, and I affirm the importance His followers must attach to religious freedom for all people – whatever their beliefs".

The 2010 Annual Dinner was held at the beautiful beach-front Hyatt in Huntington Beach on October 23, 2010. At the dinner, incoming Chair James R. Moss, Jr. thanked and presented Glen Nuttall with a plaque recognizing Glen's service to our Chapter as its Immediate Past Chair 2009-2010. Thanks was also given to departing Board Members, Roland, J. Amundson, Christopher Bauer, Robert H. Briggs, Deborah A. Gubernick and Gabe W. Pate, while incoming Board members were also recognized.

This past year's honored recipient of the J. Reuben Clark Award was Dr. John C. Eastman of Chapman University. 
