


#### MISSION STATEMENT

American Religious Freedom program at the Ethics and Public Policy Center in Washington D.C., will speak at the 8<sup>th</sup> Annual Orange County Religion and The Law Symposium on "Secularism vs. Religious Liberty: Is Recent U.S. Law and Policy Taking Sides?". In April, a First Amendment panel of local experts will teach us how to educate and defend religious liberties in the public square; in May, Karen Clemes will talk about worldwide employment law trends from the perspective of in-house LDS Church counsel. In June, the Women in the Law section will have a special gathering and speaker. In July, Joseph A. Bentley will address us on the legal relationships of the LDS Church in the Holy Land. In September, Ninth Circuit Judge J. Clifford Wallace (Ret.) will address us at our annual dinner regarding his experiences as an international ambassador for the rule of law. Finally, in November, Lowell Brown and John Schroeder interfaith collaborators will speak on Article 6 of the U.S. Constitution.

# HUGH HEWITT RECEIVES J. REUBEN CLARK AWARD AT ANNUAL DINNER

Nationally syndicated radio talk show host Hugh Hewitt received the J. Reuben Clark Award at the JRCLS-OC Chapter Annual Dinner held on October 7. 2011, at the Irvine Marriott.

Many of you will recall Professor Hewitt's gracious hosting and warm reception of Elder Dallin H. Oaks on his nationally syndicated radio show last year following Elder Oaks' speech at the 7<sup>th</sup> Annual Orange County Religion & The Law Symposium.

Professor Hewitt's ardent support of religious freedom and of the Constitution, as well as his exemplary public service and professional excellence certainly make him a worthy and honored recipient of the J. Reuben Clark Award. In this regard, Professor Hewitt's nationally syndicated radio show is heard in more than 70

markets nationwide.

He received 3 Emmys during his decade of work as co-host of the week-night television news and public affairs show Life & Times on PBS Los Angeles affiliate KCET-TV. Professor Hewitt was also the host of the PBS Series Searching For God In America, an eight-part show which premiered on PBS in Professor Hewitt is also the July 1996. author of a companion work by the same name published by Word. Professor Hewitt is the author of five other books. He is a biweekly columnist for The Daily Standard, the online edition of the Weekly Standard. Professor Hewitt served for nearly six years in the Reagan Administration in a variety of posts including Assistant Counsel in the White House and Special Assistant to the Attorney General of the United States. He was Governor Wilson's appointee to the South Coast Air Quality Management District, and was a member of the California Arts Council. Professor Hewitt appears frequently as a political and social commentator on shows including: The O'Reilly Factor, Chris Matthews, The Dennis Miller Show, The Today Show and Larry King Live. Professor Hewitt is an honors graduate of Harvard College and the University of Michigan Law School.

We appreciate Professor Hewitt's friendship and his dedicated and tireless service to many of the causes and convictions espoused by the JRCLS, as well as his willingness to speak to our members. We sincerely thank and wish Professor Hewitt and his family all the best in this New Year.
