ELDER BRUCE C. HAFEN TO SPEAK AT ANNUAL DINNER



Continuing a tradition of outstanding speakers, the Events Committee has announced that Elder Bruce C. Hafen will be the guest speaker at the 2014 Annual Dinner to be held on September 19, 2014 at the Irvine Marriott. His topic will be "Faith, Reason and the Things of Eternity".

Elder Hafen was called to serve as a member of the First Quorum of the Seventy of the Church of Jesus Christ of Latter-day Saints on April 6, 1996 and was given emeritus status in October 2010. His ties to the J. Reuben Clark School of Law go back to its beginnings in 1973 when he began teaching as a law professor, as well as serving as an assistant to the president of BYU. From 1978 to 1985 he served as the President of Ricks College (now BYU-Idaho) and then as Dean of the J. Reuben Clark Law School from 1985 to 1989. Thereafter, he served as the Provost for BYU from 1989 until his call to the First Quorum of the Seventy. Since being designated emeritus, Elder Hafen and his wife served as Temple President and Matron of the St. George Temple, from November 2010 to November 2013. Elder Hafen has authored a number of books, including The Believing Heart: Four Essays on Faith (1986), The Broken Heart: Applying the Atonement to Life's Experiences (1989), The Belonging Heart: The Atonement and Relationships with God and Family (1994), A Disciple's Life: The Biography of Neal A. Maxwell (2002), Covenant Hearts: Marriage and the Joy of Human Love (2005), and Broken Hearts: Applying the Atonement to Life's Experiences (2008). The Annual Dinner promises to be another great event and we look forward to hearing from Elder Hafen and seeing you all there.

The JRCLS-OC Chapter has enjoyed another year of outstanding events providing both interesting, informative and network-building programs and opportunities, as well as providing CLE-accredited programs to our members and guests.

In January, members heard from Neylan McBain – "How the 'I'm a Mormon' Campaign Helps Eliminate Bias: Lessons for the Legal Profession". Showing clips from a variety of ads, as well as studies, Ms. McBain, a graduate of Yale University who currently works as a brand strategist at Bonneville Communications, the agency working with the Church to produce "Mormon.org" and the "I'm A Mormon" campaign, explained to a captivated audience how the Church of Jesus Christ of Latter-day Saints has adapted its media outreach to address the perceptions of non-members and ever-changing trends in social media.

In February, we viewed the rebroadcast of the JRCLS Annual Fireside, where both Elder Bruce C. Hafen and his wife Marie shared heart-felt remarks on "Marriage, Family and the Temple".

In March, the JRCLS-OC Chapter, spear-headed by Jeffrey W. Shields, put on another well-attended, timely and relevant Religion and the Law Symposium, at Chapman University, entitled "Rights of Conscience vs. Same-Sex Rights: Religious Liberty in the Post-Prop 8 Environment", a Debate between Prof. John C. Eastman, Chair of the National Organization for Marriage and Constitutional Law Professor at Chapman University Dale E. Fowler School of Law and Prof. Lawrence E. Rosenthal, Civil Rights and Constitutional Law Professor at Chapman University Dale E. Fowler School of Law.

In April, we were favored to hear an elimination of bias presentation "Lessons from the Bench" by United States District Court Judge Josephine L. Staton who spoke on bias drawing from her vast experience as an associate and then partner at Morrison & Foerster from 1987-2002, as a Superior Court Judge in Orange County from 2002-2009, and as a United States District Court Judge from 2009 to the present.

May brought our own Gary Smith back from Utah to speak on the "Lost Legacy – The Mormon Office of Presiding Patriarch". As the son of the last Presiding Patriarch to the Church of Jesus Christ of Latter-day Saints, Eldred G. Smith, Gary shared his unique perspective and wealth of knowledge in a fascinating presentation. Gary's presentation was also particularly timely as his father had passed away just one year earlier on April 4, 2013, at the age of 106.

In July, we heard from Robert O'Brien on "Global Hot Spots". Robert, a managing partner at Ardent Fox in LA, served as the US Alternative Representative to the 60th Session of the United Nations General Assembly in 2005-2006, where he addressed the General Assembly considering the Comprehensive Convention on International Terrorism. His vast international experience advising on foreign judicial reform and elections and as a Senior Foreign Policy Advisor to Governor Mitt Romney's Presidential Campaigns allowed him to speak on global hot spots and issues currently confronting the world and its leaders.

We wish to thank all those who have taken the time to speak to the JRCLS-OC Chapter so far this year and all those who have attended the various luncheons and programs. It has been, and promises to be, an enriching experience for our members.
